Setup from 6am to 8am. The flea market is open to the public - 8am to 3pm

**Purpose:** The Flea Market is a fundraiser sponsored by the Lindbergh High School Bandstanders. This is a parents group which supports the band program. All funds raised go directly to support the band students.

**Rental Spaces:**

18' x 18' are \$30.00 before April 24th (April 24th or later \$32.00). Most spaces are located on the parking lot so you may park your vehicle in these paved spaces. You may not park your vehicle in a few of the spaces so you must unload your vehicle and then park in the general parking lot.

**Reservations:** To reserve your space, fill out the application and return with a check or money order payable to **LHS BAND** to: Bandstanders, P.O. Box 29462, St. Louis, MO 63126. Your canceled check will be your receipt. If you prefer a confirmation, please enclose a stamped, self-addressed envelope; confirmation will not be sent without the envelope. There are no refunds after receiving your application and check. Spaces are assigned in the following manner.

**Returning Fall, 2009 Flea Market vendors requesting the SAME space** who return the application before April 3rd will be assigned that space.

**Returning Fall, 2009 Flea Market vendors requesting a NEW space** who return the application before April 3rd will be given first priority for available spaces after April 3rd based on the order the application was received.

**Returning vendors from other previous Flea Markets** who return the application before April 3rd will be given second priority for available spaces after April 3rd based on the order the application was received.

**New vendors** who return the application before April 3rd will be given third priority for available spaces after April 3rd based on the order the application was received.

**All Applications received after April 3rd** will be assigned remaining available spaces based on the order of receipt. Park-in spaces may not be available for later reservations. Reserve early for the best selection.

**Additional Information and Terms.**

Check-in is from 6AM to 8AM. You will be met at the entrance and directed to your space. Vendors who have not arrived by 7:45 AM will forfeit their space, without refund, and the space will be sold to waiting vendors. **SPACES MAY NOT BE VACATED UNTIL 3PM. NO ONE MAY DRIVE THROUGH THE WALKING AISLES DURING MARKET HOURS.**

**Firearms, knives, animals, vehicles, food, beverages and items not appropriate for minors (as determined by Bandstanders) may not be sold by vendors.**

The Flea Market is held rain or shine. There is little shade and no indoor cover available, so plan accordingly.

No tables, electricity, water, etc. are provided. Indoor restrooms are available. No smoking is allowed on the premises.

**Vendors are responsible to pick up and properly dispose all trash in their designated area. Under no circumstances, should large unwanted items be left on the property at the end of the event.**

LHS Bandstanders and the Lindbergh School District are not liable for theft, damage, loss of work or personal injury.

Vendors are required to stay within their designated space. The entire space is not marked, so vendors must cooperate with each other to avoid overlaps and to provide reasonable access to adjacent spaces.

No parking is allowed in the grass, walkways or driveways. Free Parking is provided on the grounds. Parking on Lindbergh Boulevard is limited. St. Louis County Police patrol the street and often issue tickets to illegally parked vehicles. A 5-minute loading area is provided along the entry drive to allow customers to load larger purchases.

A concession stand will be open from 7 AM to 3PM. Coffee, donuts, sandwiches, drinks and snacks will be available.
